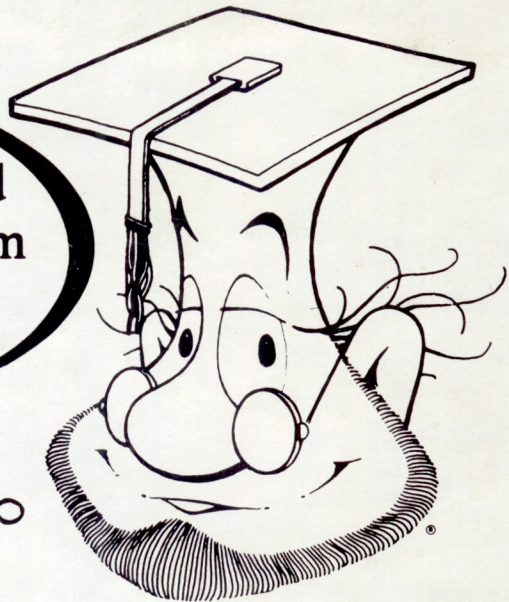

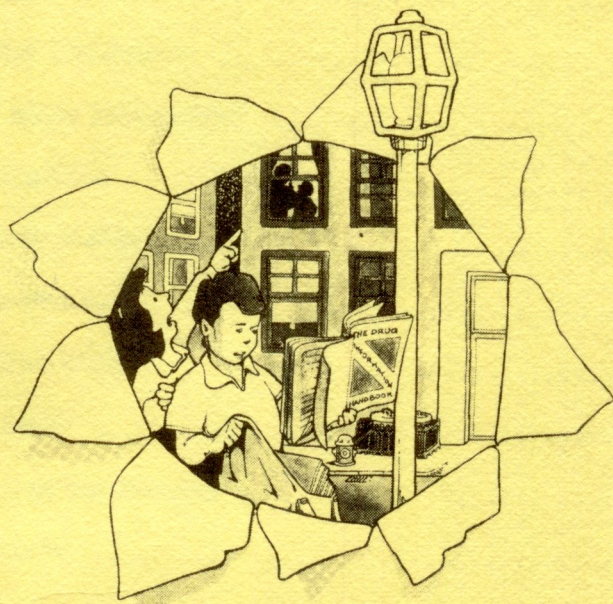

## 3. TERMS AND TERMINATION

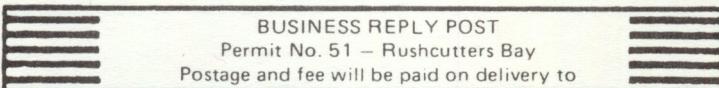
